PERSONAL DATA PROTECTION AND PRIVACY NOTICE FOR OUR VALUED CUSTOMERS

Relevance of this notice

The Personal Data Protection and Privacy Notice as set out in this document applies to the existing and prospective customers of the following entities:

- M.S. Wong & Co. (AF 0307);
- Tak Yen Management Sdn. Bhd. (206889-X); and
- Parkland Management Services Sdn. Bhd. (756695-V).

This document outlines how the above entities (hereinafter collectively referred to as "M.S. Wong & Co.") process personal data and comply with the requirements of the Malaysian Personal Data Protection Act 2010 ("PDPA"). This notice is not intended to cover categories of personal data that are not covered by PDPA.

Collection of personal data

M.S. Wong & Co. collects personal data from clients, customers, contractors and other individuals. We collect this data when it is necessary for business purposes.

The main types of personal data M.S. Wong & Co. collects relate to the contact details and organisational roles of our clients, suppliers and other business contacts. This typically includes names, addresses, telephone numbers, e-mail addresses and job titles. For company incorporation and secretarial services, we also collect I/C or Passport information, date of birth, nationality, gender, race, occupation, and information on other directorships. During the course of providing professional services to our clients, we may collect more detailed personal data. For example we may obtain financial details if we are engaged to perform financial services.

We collect most information directly from individuals when we deal with them. The personal data we collect may be provided in forms filled out by individuals, face to face meetings, email messages, telephone conversations or by third parties. If you contact us, we may keep a record of that contact.

The failure to supply such Personal Data will result in us being unable to:

- provide customers / prospective customers with the services requested;
- update you on services we offer and industry developments that may be of interest to you;
- notify you on seminars and events we are holding; and
- respond to requests related to our business and services.

Processing of personal data

The primary purposes in collecting personal data about individuals are to provide our professional services, to respond to an individual's request, to maintain contact with clients, to keep clients and other contacts informed of the services we offer and industry developments that may be of interest to them, to notify them of service offerings, seminars and events we are holding, for general management and reporting purposes such as invoicing and account management and all other purposes related to our business.

We may use personal data about individuals to market our services, including by email newsletters. However, individuals always have the opportunity to elect not to receive further marketing information from us by writing to us at

If we collect or use personal data in ways other than as stated in this policy, we will ensure we do so pursuant to the requirements of PDPA.

Disclosure of personal data

M.S. Wong & Co. does not routinely disclose personal data to other organisations unless required by law, use or disclosure is permitted by this policy, the data is necessary to provide you with a product or service which you have requested, to protect the rights, property or personal safety of any member of the public or a customer of M.S. Wong & Co. or the interests of M.S. Wong & Co. or you have given your consent.

We may also disclose non-personal, unidentifiable and aggregated information for research, survey or promotional purposes. Except as set out in this policy, we do not sell or trade personal data to third parties, or allow such third parties to use that personal data.

M.S. Wong & Co. uses a range of service providers to operate our services and our business operations. This means that individuals and organisations outside of M.S. Wong & Co. will sometimes have access to personal data held by M.S. Wong & Co. and may collect or use it from or on behalf of M.S. Wong & Co. This may include, but is not limited to, independent contractors and consultants, travel service providers, mail houses, website hosts and event managers. We will ensure that our service providers adhere to our privacy guidelines and not to keep this data or use it for any unauthorised purposes.

Transfer of data outside Malaysia

We do not perform any transfer of personal data outside of Malaysia. In an event such a transfer is required and permitted by this policy, the transfer of data does not change any of our commitments to safeguard your privacy and the information remains subject to existing confidentiality obligations.

Security of personal data

Depending on the purpose for which we have collected personal data, we may store some of the information electronically in our internal customer database. Some or all of this personal data may be available to partners and authorised staff of M.S. Wong & Co. for use in accordance with this policy.

M.S. Wong & Co. will endeavour to take all reasonable steps to keep secure any information which we hold about you, whether electronically or in hard-copy, and to keep this information accurate and up to date. We also require our employees and data processors to respect the confidentiality of any personal data held by M.S. Wong & Co. It is our policy to destroy personal data once there is no longer a legal or business need for us to retain it.

Access to information

We will provide access to personal data upon request by an individual, except in the limited circumstances pursuant to PDPA, in which it is permitted for us to withhold this information.

When you make a request to access personal data, we will require you to provide some form of identification so we can verify that you are the person to whom the data relates. In some cases we may also request an administrative fee to cover the cost of access.
